Preface

This document contains a list of the topic areas of the data items available in the 2007 NHHCS agency, patient, and medications public-use files.

NHHCS is conducted by the Centers for Disease Control and Prevention's National Center for Health Statistics (NCHS). NHHCS, which was first conducted in 1992, was inaugurated to gather, analyze, and disseminate information about long-term care provided by U.S. home health agencies and hospices, including their services, staffs, and patients. Many individuals, including elderly, post-acute, rehabilitative, and chronically ill persons access care through home health and hospice agencies.

This document is organized with survey content in mind, listing the topic areas by agency type (i.e., home health, hospice, and mixed) and by patient type (i.e., current home health patients and hospice discharges). The content grids show which topic areas were covered for which agency type and for which patient type. This list is not exhaustive, but provides the topics in which data users may be most interested. The first content grid presents topics from the NHHCS Agency module. The second grid presents survey topics covered in the Patient Health module. The final grid provides topics from the Patient Charges and Payments module.

In the grids, an "X" denotes that a question related to that topic was asked for the agency type or about the patient type. The specific wording of items can be found in the 2007 NHHCS survey instruments and variable names are in the documentation; both are available on the NHHCS home web page at http://www.cdc.gov/nchs/nhhcs.htm. There, you will also find technical notes about the survey.
