

Long Term Care Facility Reporting Requirements and Guidance

Long-term Care Facility Component (LTCF): Track infections and prevention process measures, systematically, to identify problems, improve care, and determine progress toward national healthcare-associated infection goals.

CMS reporting requirements for Long-term Care Facilities

Title	Link	Reporting Frequency
LTCF Component: Respiratory Pathogens and Vaccination Module: Residents	Respiratory Pathogens and Vaccination Module LTCF NHSN CDC	Residents: Data for the current reporting week should be entered on or before the Sunday of the following reporting week (data are due by the following Sunday) COVID-19, Influenza, and RSV case, hospitalization, and vaccination data are required.
LTCF Component: Respiratory Pathogens and Vaccination Module: Healthcare Personnel	Respiratory Pathogens and Vaccination Module LTCF NHSN CDC	Healthcare Personnel: Report COVID- 19 vaccination data for at least one reporting week per month, due quarterly.
Healthcare Personnel Safety Component: Influenza Vaccination summary	HCP Flu Vaccination HPS NHSN CDC	Report once per annual influenza season.

Monthly Reporting Plan	Instructions for Completion of LTCF Monthly Reporting Plan	Monthly (required for each month the facility plans to report data)
Monthly Summary Data	Instructions for Completion of LTCF Monthly Summary Data	Monthly (this is completed at the beginning of the month for data from the month prior)
Annual Facility Survey	Instructions for Completion of LTCF Component Annual Facility Survey	Upon initial enrollment and annually thereafter (facilities are required to complete the survey by March 1st) or prior to reporting in the HAI Module (non COVID-19 module).
