

Adding Monthly Reporting Plans in the NHSN Application

Outpatient Procedure Component

Note: These instructions assume your facility is enrolled with NHSN.

Background: Outpatient Procedure Component Monthly Reporting Plans are used by NHSN facilities to inform CDC which Outpatient Procedure Component modules are used during a given month.

Adding Monthly Reporting Plans in the NHSN Application

- 1. To add an Outpatient Procedure Component (OPC) Monthly Reporting Plan:
 - a. Click **Reporting Plan** on the left-hand side of the OPC Home Page.
 - b. Select Add under the month you want to add a plan.
